# Job Summary:

The DVS program provides counseling, legal assistance, emergency shelter, housing and job search assistance, food, clothing and transportation for survivors of domestic abuse and their children. Under broad supervision, the Domestic Violence Shelter Specialist works directly with clients and their children at the emergency shelter. Services to clients include the 14 shelter-based standards set by California law. Domestic Violence Case Manager works directly with clients and their children ensuring the implementation and success of their case plan.

#### Duties/Responsibilities:

- Ensures all paperwork is completed for clients entering and exiting the shelter
- Works with DVS Coordinator and client to develop a case plan for each client
- Works with client to ensure implementation and success of case plan
- Give clients appropriate referrals and follows up to ensure services have been received
- Works with agencies and service providers to facilitate case coordination and information sharing s appropriate
- Provides on-going education to client in the form of verbal and/or written or educational materials
- Follows up with client to determine needs and success
- Role model appropriate relationships, behaviors, parenting techniques, etc.
- Provide individual para-professional counseling sessions with clients, and children when appropriate
- Provide case management during staff meetings regarding client needs and issues
- Assist clients with temporary restraining orders as needed
- Provide court advocacy/accompaniment with clients during legal proceedings
- Respond to emergency situations pertaining to shelter during/after regular working hours.
- Provide emergency transportation as needed
- Reinforce shelter safety rules with clients and inform DVS Coordinator of unsafe situations as they arise
- Develop policies pertaining to the shelter
- Responsible for purchasing food and supplies using cost saving measures at all times
- Ensure shelter is clean and orderly by encouraging clients to maintain shelter cleanliness
- Ensure maintenance and upkeep of the shelter including scheduling repairs
- Use culturally sensitive and appropriate language with clients
- Maintain client confidentiality with other agencies and general public
- May be required to stay overnight at the shelter. This may include weekends and holidays.
- Be available once a month (1-week) to be on-call during non-business hours
- Perform intake of clients at shelter and as needed in the office
- Responsible for working at the shelter at least ½ of the work day when the shelter is occupied
- Provide case management for clients residing in the shelter
- When the shelter is empty, this position will provide case management for clients engaged in outreach services
- Inform supervisor of any unusual situations that arise and provide solutions to issues
- Develop and help with implementation with DV Month Awareness and other outreach events
- Must complete all required paperwork and data entry
- Act as a mandated reporter of child abuse while performing job responsibilities
